DRESSING & BEAUTIFICATION SALOONS Tariff 6

Effective 1st January 2018.

1. Scope of Tariff

This tariff shall apply to public performance of musical works and sound recordings at Dressing and Beatification Saloons including but not limited to Barbering, Toe and Nail, Men Dressing, Spa, Hair Making Parlours and Tattooing & Tanning Salons.

2. General Conditions

- 2.1. An applicant for a Licence under this tariff shall complete Form 6-DBS and furnish the Society with such information as may be required to enable it apply the due tariff to the use of music on the premises.
- 2.2. In the case that the applicant fails or is unable to provide the required information, GHAMRO reserves the right to make use of basic data provided by the industry to the extent of variations in this tariff as it considers appropriate when licensing which in the opinion of the GHAMRO relates to the use.
- 2.3. The Society through its representative will have the right of entry to the licensed premises at reasonable times, and without prior notice, for the purpose of observing and accessing the usage of music.
- 2.4. GHAMRO is not bounded to apply this Tariff for the licensing of the uses mentioned in the case the applicant is found to have used music and continue to do so without license under Section 36 of LI 1962 and reserves the right to make such variations including the charge of penalties as it deems appropriate.

3. Fees

- 3.1. For the purpose of this Tariff a Flat Fee comprising the **License Fee** provided under the Ghamro Schedule of Fees and **Royalty payable** is determined by reference to the use types provided under paragraph 1.1 of this Tariff. In the event the applicant is unable to provide requisite information within the time limit provided under paragraph 2.1 this following minimum rates shall apply under this Tariff.

4. Inflation adjustment of Minimum Royalty Fees

The minimum royalty Fees payable under 2.3 (ii) above in this tariff will be adjusted on the 1st of January of each year and on each anniversary year of the licence by the mean. (to the nearest whole percentage point) of the percentages by which the Consumer Price Index changes.

5. Tariff Duration

This Tariff is effective from 1st January, 2018 to the 1st of January, 2021 and will be subject to yearly inflation adjustment as provided under paragraph 4. On the anniversary of the approval by the Board of Director of the Ghana Music Rights Organization (GHAMRO) entire Tariff would be reviewed.

6. Tariff Duration

This Tariff is effective from 1st January, 2018 to the 1st of January, 2021 and will be subject to yearly inflation adjustment as provided under paragraph 4. On the anniversary of the approval by the Board of Director of the Ghana Music Rights Organization (GHAMRO) entire Tariff would be reviewed.
