The Licence Fee is payable annually, in advance, within 30 days of the date of invoice based on information provided by the Company which it warrants that is true, correct and up to date.
- 1.2. GHAMRO may amend the Tariff and Licence Fee payable, subject to any such amendment of the information contained in this Form by the Company and any increased Fee that becomes payable as a result of a change in the manner and extent of the usage of GHAMRO's Repertoire, the Company undertakes to honour within 30 days of invoice any invoice by the Society.
- 1.3. GHAMRO will have the right, at any time during the subsistence of the Agreement, to reassess and check the Licence Fee payable by the Company and the parameters upon which the Licence Fee is payable.
